Registration Information is as follows:

When: November 1st, 4th, 9th and 15th, 2021 between 5pm and 7pm.

Where: At the **Lee County Sheriff's Office, 1900 Frederick Road, Opelika, AL 36801.**
These are the only times that applications will be accepted.

The applicants will need to bring the following documents at the time of registration:

- 1) Children's birth certificates
- 2) Proof of residency
- 3) State issued picture ID or Passport
- 4) Court issued guardianship papers if applicant is not the parent

The child/children must be between the ages of **2 years old and 9 years old.**

If the child/children are currently on another Christmas Program, if they have been on our program for 3 of the past 5 years, or are not residents of Lee County, AL they will not be eligible for our program.
